- 6) Discussion, possible action or staff direction on approving the agreement with Taurus Technology Investment Partners, Inc. for IT Outsourcing and Staffing Agreement: Chief Keller informed the Board that the agreement is for \$24,000 and includes a designated IT person, a better internet service and phones.

Ms. Cook stated that the finalized budget will be presented at the next Regular meeting.
