1. Call to Order

Board Chair Dave Curtis called the meeting to order at 9:05 AM.

- 4. Call to the Public.

- 5. Approval of Minutes
 - **a. January 7, 2016:** Board Member Taylor made a motion to approve the Minutes from the January 7, 2016 meeting. Board Member Ernster seconded. Motion passed unanimously.
- 6. <u>Discussion, possible action or staff direction on appointing City of Cottonwood City Manager Doug Bartosh and Sedona Board Member Dave Soto to the committee:</u> Board Member Taylor made a motion to appoint City of Cottonwood City Manager Doug Bartosh and Sedona Board Member Dave Soto to the committee. Board Member Ernster seconded. Motion passed unanimously.
- 7. Discussion, possible action or staff direction on Clarkdale, Camp Verde, Montezuma Rimrock Fire Districts status and representation on the Greater Verde Valley Emergency Services Sub-Committee: Chief Keller stated that the committee could reduce the number of members by 4 with the newly formed JPA between MRFD and CVFD and the Consolidation between Verde Valley and Clarkdale.

Chief Keller stated that the Clarkdale members resigned from the Board as of May 20th.

Chairperson Kleindienst nominated Carol Keeton and Dave Curtis to represent CCFMA.

Board Member Taylor stated that he will resign from the committee.

Board Member Curtis made a motion to accept the resignation of the Clarkdale members. Board Member Keeton seconded. Motion passed unanimously.

8. <u>Discussion, possible action or staff direction on inviting Verde Valley Ambulance Company to have</u> representation on the Greater Verde Valley Emergency Services Sub-Committee: Chief Keller stated that

they would like to invite VVAC to have representation on the Greater Verde Valley Emergency Services Sub-Committee.

Chief Hazime stated that VVAC was part of the operations and it makes sense for them to be part of shared services.

Chief Kazian sees this committee as a 'Steering Committee' and if we have other interest we should invite them to have representation.

Board Member Curtis made a motion to extend an invitation to VVAC to have representation with the Greater Verde Valley Emergency Services Sub-Committee. Chairperson Kleindienst seconded. Motion passed unanimously.

9. Update and discussion with possible action or staff direction on current projects and programs being reviewed by the Chiefs: Assistant Chief Piechura stated there has been discussion for a fleet and maintenance program. He stated that they are putting together and RFQ to providers in the Verde Valley. Assistant Chief Piechura stated that they have also been looking into a purchasing consortium.

Chief Kazian stated that they are possibly looking into a facility or place for service. He also stated that the Chiefs will bring all the ideas forward from the Chief meetings.

**The Consensus of the committee was to meet quarterly.
